Guidance notes on completing Part 3 of the Annual Governance and Accountability Return 2020/21

1. Every smaller authority in England that either received gross income or incurred gross expenditure exceeding £25,000 **must** complete Part 3 of the Annual Governance and Accountability Return at the end of each financial year in accordance with *Proper Practices*.
2. **The Annual Governance and Accountability Return is made up of three parts, pages 3 to 6:**
 - The **Annual Internal Audit Report** must be completed by the authority's internal auditor.
 - **Sections 1 and 2** must be completed and approved by the authority.
 - **Section 3** is completed by the external auditor and will be returned to the authority.
3. The authority **must** approve Section 1, Annual Governance Statement, before approving Section 2, Accounting Statements, and both **must** be approved and published on the authority website/webpage **before 1 July 2021**.
4. An authority with either gross income or gross expenditure exceeding £25,000 or an authority with neither income nor expenditure exceeding £25,000, but which is unable to certify itself as exempt, or is requesting a limited assurance review, **must** return to the external auditor by email or post (not both) **no later than 30 June 2021**. Reminder letters will incur a charge of £40 +VAT:
 - the Annual Governance and Accountability Return Sections 1 and 2, together with
 - a bank reconciliation as at 31 March 2021
 - an explanation of any significant year on year variances in the accounting statements
 - notification of the commencement date of the period for the exercise of public rights
 - Annual Internal Audit Report 2020/21

Unless requested, do not send any additional documents to your external auditor. Your external auditor will ask for any additional documents needed.

Once the external auditor has completed the limited assurance review and is able to give an opinion, the Annual Governance and Accountability **Section 1, Section 2 and Section 3 – External Auditor Report and Certificate** will be returned to the authority by email or post.

Publication Requirements

Under the Accounts and Audit Regulations 2015, authorities must publish the following information on the authority website/webpage:

Before 1 July 2021 authorities **must** publish:

- Notice of the period for the exercise of public rights and a declaration that the accounting statements are as yet unaudited;
- **Section 1 - Annual Governance Statement 2020/21**, approved and signed, page 4
- **Section 2 - Accounting Statements 2020/21**, approved and signed, page 5

Not later than 30 September 2021 authorities **must** publish:

- Notice of conclusion of audit
- **Section 3 - External Auditor Report and Certificate**
- **Sections 1 and 2 of AGAR** including any amendments as a result of the limited assurance review.

It is recommended as best practice, to avoid any potential confusion by local electors and interested parties, that you also publish the Annual Internal Audit Report, page 3.

The Annual Governance and Accountability Return constitutes the annual return referred to in the Accounts and Audit Regulations 2015. Throughout, the words 'external auditor' have the same meaning as the words 'local auditor' in the Accounts and Audit Regulations 2015.

Guidance notes on completing Part 3 of the Annual Governance and Accountability Return (AGAR) 2020/21

- The authority **must** comply with *Proper Practices* in completing Sections 1 and 2 of this AGAR. *Proper Practices* are found in the *Practitioners' Guide** which is updated from time to time and contains everything needed to prepare successfully for the financial year-end and the subsequent work by the external auditor.
- Make sure that the AGAR is complete (no highlighted boxes left empty), and is properly signed and dated. If the AGAR contains unapproved or unexplained amendments, it may be returned and additional costs will be incurred.
- The authority **should** receive and note the Annual Internal Audit Report before approving the Annual Governance Statement and the accounts.
- Use the checklist provided below to review the AGAR for completeness before returning it to the external auditor by email or post (not both) no later than 30 June 2021.
- The Annual Governance Statement (Section 1) must be approved on the same day or before the Accounting Statements (Section 2) and evidenced by the agenda or minute references.
- The Responsible Financial Officer (RFO) must certify the accounts (Section 2) before they are presented to the authority for approval. The authority must in this order; consider, approve and sign the accounts.
- The RFO is required to commence the public rights period as soon as practical after the date of the AGAR approval.
- Do not send the external auditor any information not specifically requested. However, **you must inform your external auditor about any change of Clerk, Responsible Financial Officer or Chairman, and provide relevant authority owned generic email addresses and telephone numbers.**
- Make sure that the copy of the bank reconciliation to be sent to your external auditor with the AGAR covers all the bank accounts. If the authority holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree the bank reconciliation to Box 8 on the accounting statements (**Section 2, page 5**). An explanation **must** be provided of any difference between Box 7 and Box 8. More help on bank reconciliation is available in the *Practitioners' Guide**.
- Explain fully significant variances in the accounting statements on **page 5**. Do not just send a copy of the detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include complete numerical and narrative analysis to support the full variance.
- If the external auditor has to review unsolicited information, or receives an incomplete bank reconciliation, or variances are not fully explained, additional costs may be incurred.
- Make sure that the accounting statements add up and that the balance carried forward from the previous year (Box 7 of 2020) equals the balance brought forward in the current year (Box 1 of 2021).
- The Responsible Financial Officer (RFO), on behalf of the authority, **must** set the commencement date for the exercise of public rights of 30 consecutive working days which **must** include the first ten working days of July.
- The authority **must** publish on the authority website/webpage the information required by Regulation 15 (2), Accounts and Audit Regulations 2015, including the period for the exercise of public rights and the name and address of the external auditor **before 1 July 2021**.

Annual Internal Audit Report 2020/21

During the 2020/21 Accounting year the authority's turnover exceeded £200,000. As a result of this the AGAR report has been prepared by the RFO on an income and expenditure basis rather than a receipts and payment basis used in previous periods. As a result of this Section 2 of the AGAR report (Accounting statements) shows a 2021 brought forward figure of £141,598, restated from the carried forwards balance last year of £138,820. The difference represents the brought forwards debtors movement.

Internal Control Objective B

In accordance with the financial regulations, it is normal practice for an appointed Councillor (usually the Chairman of the Finance Committee) to undertake a series of finance checks at least quarterly and report findings to the council at the following meeting. These checks would confirm the Bank reconciliation, Payroll, Cash controls, Petty Cash, Wage reports, VAT reports and Budgetary controls. However, records provided indicate that this was only performed up to the 30 September 2020.

The reports including reconciliations were still prepared by the RFO for all months of the year. These reports were subsequently available to the council at the following meetings. It should be noted, that payments were processed in a timely manner by the RFO and that online bank authorisation of the payments were still carried out by two separate councillors as required. Council minutes show the approval of payments. However, the additional level of financial oversight for part of the year was missing, which would make it harder for the council to prevent and detect inaccuracies and fraud.

Internal Control Objective K

The authority was not exempt and had a limited assurance review of its 2019/20 AGAR.

Internal Control Objective L

Authority has annual turnover exceeding £25,000. However, payment list and reconciliations are provided on the council website.

Annual Governance Statement: Explanation of Section 2, Part 2 – ‘No Response’

The Chairman of the Town Council's Finance Committee is tasked to undertake a monthly Internal Finance inspection. From November 2020, when the Second National Lockdown was introduced, the current Finance Chairman, Cllr D J Hayward, was unable to carry out this inspection. He did not carry out the inspection until April 2021 when the Third Lockdown was eased and he felt able to attend the Offices.

As RFO, I brought this to the attention of the Chairman and Members of the Town Council and subsequently the Internal Auditor, Tom Stuckey from Thomas Westcott.

In addition to Cllr D J Hayward, four other Members of the Town Council are signatories on the Council's Current Bank account and they have online access to the Council's Bank Statements to enable them to authorise payments made by internet banking. Each month all Members of the Town Council are presented with bank reconciliations and a list of payments made during the month. I feel this mitigates the lack of the Internal Finance Inspection somewhat, but obviously not entirely.

Cllr D J Hayward has since undertaken an inspection and has been made aware of the importance of his position but if he is unable to undertake future inspections, I will ask the Chairman of the Council to carry them out.
