20.074 Public Speaking Time

Mr K Wood spoke on behalf of Budleigh Salterton Football Club as Club Secretary. He explained that the Club was run by volunteers and provided young people with a place to play sport, including coaching for youngsters aged 5 to 14 years. The Club was highly regarded by the Devon Football Association because of its great facilities.

He explained that the floodlights were 20 years old and were badly corroded – one was unsafe and unusable and the others were in a poor state. The cost of replacing them all would be in the region of £15000 to £20000.

The Club had asked the Devon FA for a Grant, had contacted a local charitable trust and were also fund-raising.

20.080 Budleigh Community Workshop Trust

Consideration was given to using Community Infrastructure Levy (CIL) Receipts for all or part of the agreed Grant to the Trust.

The Town Mayor, Cllr M C Hilliar confirmed that the Council had already agreed to a Grant of £25000 and this discussion was to decide whether it should be paid from CIL Receipts or Town Council Reserves.

After a lengthy discussion it was

Resolved: The Grant will be paid from CIL Receipts on the condition that it is

included in a CIL Delivery Plan which is to be produced by the CIL

Committee at the earliest opportunity.

Members then considered whether to ask the Trust to sign a Grant Funding Agreement (GFA).

Examples of two GFAs had been circulated prior to the Meeting. The Town Mayor, Cllr M C Hilliar explained that both had been written by East Devon District Council; one had been used for the S.106 Monies paid to Knowle Village Hall for the playground refurbishment and the other was a newly updated version. He also explained that a GFA would enable the Council to reclaim its Grant if the project failed and the Trust had to sell the former Fire Station. It was

Resolved:

The wording from both documents will be amalgamated into one document. Cllr D J Hayward and Cllr G Turner both said they would be happy to assist the Clerk with the preparation of any such document.

20.081 Request for Grant Aid 2020/21: Budleigh Salterton Football Club

Consideration was given to making a donation to the Club to help fund the purchase of replacement floodlighting.

20.083 Any Other Business at the Chairman's Discretion

- Cllr Mrs M P Lewis advised that she had attended a meeting of the Budleigh Salterton Covid Support Group:
 - The Hub was staring to see an increase in requests for support but so far had sufficient capacity to deal with this. They were still carrying out assisted shopping trips and telephone befriending. They had reported that anxiety levels were increasing.
 - The Group's finances were still healthy, and nine households were being supported. The average time that households were needing support seemed to be 18 weeks.
 - All was well at St Peter's School.
 - The surgery was coping well with no change in cases; this was mostly because residents were following the restrictions. The 'flu clinics had gone really well, again this was because all had "done as they were told"!
 - o The Group would continue to meet on a fortnightly basis.
- Cllr Mrs Lewis then reported that she had attended a meeting of the Local Action Group. She explained that the multi-agency Group had not met since the start of the COVID-19 crisis and the last meeting had only been attended by Insp A Weeks and three councillors! A lot of the meeting had been taken up with issues in Exmouth and the only item which related to Budleigh Salterton was the possible installation of a left-hand priority lane out of Liverton Business Park which should help with congestion.
- Cllr D J Hayward thanked the Clerk for her time earlier that day when they had made a start on the budgets for 2021/22.
