22.325 Public Speaking Time

22.332 Any other Business at the Chairman's Discretion

- The Chairman, Cllr R D Sherriff updated Members on the Lower Otter Restoration Project. He said that the reason a large portion of the Lime Kiln has been closed off was to allow South West Water and Kier to drill for a storm water drain along north side of the spit and under Otter Head. The area would be used for the storage of pipes which will be installed shortly. It was hoped the work would be done before spring.
- Cllr Sherriff then advised that the work at Otter Head was to create an inspection pit and cover to enable easy access in the future. The road which had been installed was temporary and had not gone over the Roman villa; an archaeologist was on site to keep an eye on progress. It was hoped that this work would be completed by Easter.

Cllr Mrs M P Lewis asked how certain was it that the work would be finished by Easter as the town would not want to lose vital parking during the start of the season.

Cllr Sherriff advised that the liaison officer from Kier had spoken to local businesses, explaining that the work had been affected by poor weather.

Cllr Mrs Lewis said that pressure needed to be kept up on Kier.

Cllr A L Jones said it was good to hear that the car park would be clear soon. He had been concerned when he had seen the excavation work and hoped it would not interfere with the storage pit already under the car park, installed as part of the Clean Sweep project.

Cllr Sherriff also added that the car park would be relined once work was concluded.

- Cllr R J Doorbar asked if regular reports were received from Kier and was there someone who could come and speak to the Town Council. Cllr Sherriff confirmed that he and District Cllr T D Wright were on the Stakeholder Group and would pass on any important information to Councillors. However, there was a liaison officer and information on the LORP website. Cllr Doorbar said that there needed to be other methods of finding out information, rather than websites, for the more elderly residents of the town. It was good there was someone available to respond to any grumbles which might seem minor but if not answered tended to lead to more major complaints.
- Cllr Doorbar then asked what was happening at the Longboat Café where the covered area seemed to have encroached into the Shelter.
 Mrs J E Vanstone explained that an enforcement notice had been issued to the person running the café requesting that the covered area be removed as it was in breach of planning rules.
- Cllr R A Harris advised that there would be disruption throughout the town as Wales & West renewed the gas pipes in the town.

There being no further business, the Meeting closed at 7.20pm.
