# 23.114 Chairman's Report

The Town Mayor, Cllr D J Hayward reported:

- He had visited the Community Gardens to assist with the inspection process with Cllr A F Chaplin and Cllr R D Sherriff. He had been very impressed with the overall standard of plots and those needing a bit of extra work were known to Cllr A F Chaplin, who had a good relationship with all the tenants. He felt the town was lucky to have a slice of the Good Life in its back yard.
- He had attended a Reception at CTCRM Lympstone. It had been an enjoyable evening and the entertainment included an unarmed combat display and concluded with the world-famous Royal Marine Band. He was thankful there are such disciplined men and women, who are willing to put their lives on the line on our behalf. He said if anyone ever had the opportunity to attend such an event, they should grab it with both hands!

## 23.115 Clerk's Report

Mrs J E Vanstone reported:

- She had received notification from East Devon District Council of another event consultation. She would will forward details the next day as a response was needed by 29 July.
- An up to date version of the Good Councillors Guide was available online. Hard
  copies were also available and she asked members to let her know if they
  required a copy.
- The work on the Hall floor was going well. The floor had been sanded and the first three coats of lacquer were completed. The last coat would be done later in the week.
- The caretaker, Steve, was unwell and she was not sure how long he would be away from work so she would be asking for help during this time.

# St Peter's School

Cllr M C Hilliar reported that he had received a year-end report from the Head Teacher of St Peter's School – a copy of the report (cm0723 st peters) is available on request from the Town Council Offices.

#### Civic Service

Deputy Town Mayor, Cllr Mrs C A Sismore-Hunt thanked everyone for attending and she was pleased to report that the collection had raised £147 for RNLI.

#### Friends of Budleigh Salterton Library

Cllr D Walsh advised the Group was hoping to have a book stall at the seafront fayre, organised by the Lions Club on August Bank Holiday Monday. There had been some issue regarding insurance but this had been sorted out.

## 23.117 Reports of County and District Councillors

## **County Councillor**

Mrs J E Vanstone read the report from County Cllr Mrs C Channon:

- The Traffic Orders for East Budleigh Road, Boucher Road and Bedlands Lane (opposite Frewins) were all agreed at the July HATOC meeting.
- She had been promised that the Traffic Order for High Street, agreed last year, should be in place by the end of September.
- She had been informed that Station Road and Upper Stoneborough Lane will be resurfaced between 24-28 August.
- She thought it would be sensible to ask Kier to bring back the Traffic lights whilst the work is done in Lime Kiln Car Park in August.

## **District Councillors**

District Cllr H Riddell thanked the Deputy Town Mayor, Cllr Mrs C A Sismore-Hunt and Town Clerk for organising the civic service; it had been nice to see everyone. He then reported:

- He had received an apology from one of the operations managers at StreetScene regarding the grass cutting issues on The Green. Some of the areas had been missed and the team had been sent back to complete the work.
- The issue with bin collection at Frewins had been resolved, with letters being sent to residents. An additional slim access lorry was to be delivered soon but the team would prefer to get the parking issue sorted rather than use the new vehicle.
- He and his fellow Ward Members had visited the Youth Club. The Club was nearly full up and continuing to do great work. The Budleigh Community Youth Project were giving up the Venture Hall and it was being bought by Devon County Council.

- He and District Cllr Ms C Fitzgerald were speaking with East Devon District Council (EDDC) officers regarding the land behind the play park on Greenway Lane which could be used as an additional play area.
- He was pleased to advise that he had been appointed to the Board of Governors of St Peter's School.

#### District Cllr Ms M Martin reported:

- The LORP project was in its final stages and the works site offices would shortly be moving to Lime Kiln car park. The footpath bridge leading to Lime Kiln was almost complete, after which the waterway will be allowed to breach in stages so that wildlife which is settling upstream will not be disturbed. The process is expected to be complete by October. The next LORP liaison meeting would be organised when needed. She and her fellow Ward Members had received an email from Richard Easthope, EDDC Parking Services Manager, regarding the work to install the footbridge which the Clerk had forwarded to Members.
- She had visited Budleigh Youth Club with District Cllr H Riddell and District Cllr Ms C Fitzgerald and had been asked to join the Board of Trustees.
- Devon County Council Highways Officer Mike Brown had advised that the
  potholes on Sanctuary Lane, Woodbury would soon be repaired and the road
  resurfaced next year. She and County Cllr Jess Bailey would be keeping an
  eye on this!
- The EV Chargers in the town were now operational.
- At the recent Council Meeting she had put forward four questions:
  - To the Leader of the Council, Cllr P Arnott, requesting the inclusion of Swift bricks in future house builds. Cllr Arnott had responded that this could be for the Strategic Planning Committee to consider when the final draft of the Local Plan is taken forward to an examination in public.
  - To the Leader of the Council, Cllr P Arnott, regarding banning snares on all council owned land; this was now going to the Overview Committee for scrutiny.
  - Two questions to the Housing Portfolio Holder for Sustainable Homes. One question was requesting that empty properties were not advertised until ready for letting and the second was a request that Service Level Agreements be put in place so that shorter timescales were aggressively aimed for; this suggestion was put off until 'performance levels had improved'.

Cllr D J Hayward added that the EV chargers in the Lime Kiln Car Park were on Zap-Map but the ones in Rolle Mews Car Park were not.

## District Cllr Ms C Fitzgerald reported:

- She too had attended the Civic Service which she had enjoyed.
- On 31 July there would be a 'Love Parks' event on The Green. It was a day of free activities for all the family including kite flying and a scavenger hunt.
- She was keen to get involved with Budleigh Salterton Traffic Group. The Clerk said she would keep Cllr Fitzgerald informed of meeting dates etc.
- The Strategic Planning Committee had met a couple of times and was looking at pulling together feedback following the Local Plan consultation. The next step would be to analyse the comments so they can build the Local Plan. The deadline was to get to inspection stage in early 2025 but if that date was not achieved the process will have to start again.

The Town Mayor, Cllr D J Hayward advised that the sign for Rolle Road was missing. The Clerk said she would report this.

Cllr Hayward also commented on the state of the drains along Exmouth Road/West Hill/High Street all of which needed clearing.

## 23.118 Finance Inspection

- (i) Payments for the month of July 2023, in accordance with Appendix A, were approved.
- (ii) It was noted that the Chairman of the Finance Committee had carried out the internal finance inspection for June 2023.

Cllr Mrs L D Evans asked the newer Councillors to note that the rates on the Upper Station Road Car Park were more than those for the Public Hall so the "free" car park was not actually free!

Updated quotations for the installation of a seafront webcam, to be located at Rosemullion Court, were received and considered. After a lengthy discussion it was **Resolved:** The decision will be deferred until the various questions relating to data

protection, public safety and storage of information are to hand.

### 23.124 Lengthsman

Consideration was given to employing a contractor/individual to carry out lengthsmantype duties (in addition to the Town Maintenance operative).

**Resolved:** The decision will be deferred until a full list of the proposed tasks is to hand

#### 23.125 War Memorial

Consideration was given to obtaining quotations to clean the War Memorial.

The Deputy Town Mayor, Cllr Mrs C A Sismore-Hunt advised that the memorial has to be professionally cleaned as detergent could damage the granite, which can no longer be sourced. It was

**Resolved:** The Clerk should obtain quotations to clean the Memorial and Commemorative Plague.
