### **CC/44 Apologies for Absence**

Apologies were received and accepted from the Town Mayor, Cllr D J Hayward, District Cllr Ms C Fitzgerald, Ms J Moore (St Peter's School) and Mrs K McDermott-Darley (Budleigh Community Workshop Trust).

County Cllr Mrs C Channon and Cllr J Tresidder (East Budleigh with Bicton Parish Council) were not present.

### **CC/45 Minutes**

**CC/51 Any Other Business at the Chairman’s Discretion**

- Mark asked if any progress had been made regarding the sale of single use barbecues and the possibility of banning their use on the beach. Jo read the response she had received from the East Devon District Council Beach Safety Officer and suggested that she contacts him again following the change of Ward Members. Keith added that purpose-built bins were available specifically for used barbecues and wondered if EDDC could provide some. It was agreed that better signage asking beach users to think of other users’ safety and the beach environment would be beneficial.
- Bob reported that the OVA would be providing the school with a variety of bird boxes (for robins, sparrows and blue/long-tailed tits) and they were due for delivery in the next week or so.
