18.287 Election of Chairman

Only one nomination had been received, that of Cllr C Richards, proposed by Cllr A L Jones and seconded by Cllr Mrs C A Sismore-Hunt.

The Town Mayor, Cllr T D Wright declared that Cllr C Richards be appointed as Chairman.

18.288 Public Speaking Time

18.289 Apologies for Absence

Apologies were received from Cllr C A Kitson (holiday).

18.290 Minutes

The Minutes of the Meeting of the Finance Committee held on 9 April 2018 had been circulated prior to the Meeting. It was unanimously agreed they be signed as a true record.

18.291 Chairman's Report

Cllr C Richards advised that there was nothing material to report other than the current budget which would be covered later in the Meeting.

18.292 Precept 2019/20

(i) The estimated figures for the period 1 April to 30 September 2018 were received. Cllr Richards went through all the Budget Headings and explained any major variances.

(ii) The Precept Requirement for financial year 2019/20 was considered. The figures presented indicated a requirement for £114,500.

Resolved: Recommend to the Town Council that the Precept Requirement for the year 2019/20 should be £114,500.

The Town Mayor, Cllr T D Wright thanked Cllr Richards for his continued financial management and clear explanation of the Council's income and expenditure.



18.293 Direct Debit Payments

Cllr C Richards advised that the Council needed to formalise that the following expenditure items could be paid via direct debit:

Resolved: All the items listed above are to be paid via direct debit for the next twelve months

18.294 Internal Controls

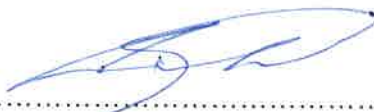
