#### **18.467 Minutes**

The Minutes of the Meeting of the Community Infrastructure Levy Committee held on 29 October 2018 had been circulated prior to the Meeting. It was unanimously agreed they be signed as a true record.

#### 18.468 S.106 Funding

Cllr C A Kitson said he had received information from the EDDC Planning Obligation Officer with details on how the money can be spent. He then updated members on the remaining S.106 projects:

- The Knowle Village Hall Playground project was progressing very well. The
  committee was in the process of putting together a planning application for
  the whole project rather than just for the outdoor table tennis table. They
  were waiting for the necessary approvals from Clinton Devon Estates and as
  soon as these were received they would submit the application.
- The skate park was almost ready to go to tender. He hoped there would be some consultation with the various users before any final decisions were made as to equipment and design.

The Town Mayor, Cllr T D Wright said that the District had been very pleased with the contractors used for the Phear Park skate park in Exmouth and they might use them again. He reassured Cllr Kitson adding that skate boarders, BMX users and inline skaters had been contacted.

Cllr Kitson suggested that it might be useful if some of the Lime Kiln users could visit Phear Park to see which pieces of equipment they would prefer.

Cllr Kitson said that the next activity would be a meeting with the Planning Obligation Officer to discuss funding for the play parks at Norman Crescent and Deepways to see what future investment might take place at these locations.

The Clerk added that there was also money available for public artwork at Norman Crescent but there were some issues to overcome before that could go ahead.

Cllr C A Kitson concluded that each Committee member had information on CIL and he asked that they keep this as the rules of spending this funding were very different from S.106 funding.
