Organisation Aims and Objectives

The Club is committed to:

- Player development and progression.
- Community engagement through football.
- Entry into local league and cup competitions.
- Promoting values such as teamwork, sportsmanship, personal growth, fun, and fitness.

Service Description

- Weekly Training Sessions – Structured coaching sessions led by qualified volunteers, focusing on skill development, teamwork, fitness, and confidence-building.
- Competitive & Friendly Matches – Opportunities for players to compete in local leagues, tournaments, and friendly fixtures, appropriate to their age and ability.
- Player Development Pathways – A focus on individual progression, with coaching tailored to different age groups and abilities, ensuring players develop at their own pace.
- Grassroots Youth Football Opportunities – Inclusive sessions to encourage participation from all young players.
- Community Engagement & Events – Organising football and social events, and community initiatives to bring families together.
- Coach & Volunteer Development – Providing training and support for parents and volunteers who wish to get involved in coaching, refereeing, or club operations.
- Safe & Enjoyable Environment – Adhering to FA safeguarding standards, ensuring all coaches and volunteers are DBS-checked and trained in child welfare.
- Affordable & Accessible Football – Keeping costs as low as possible and seeking funding or sponsorship to provide opportunities for all children, regardless of background.

Project Details

Budleigh Salterton AFC Youth is seeking to develop a section of land adjacent to the club's ground into a dedicated space for youth football. This land is large enough to accommodate two 5 v 5 pitches, or one 7 v 7 pitch, or one 9 v 9 pitch to use for matches. Meaning we can accommodate matches for ages from under 6s up to and including under 12s. The space will also be suitable for training children of all ages.

The space will be used year-round, providing a safe and accessible environment for young players to develop their skills, participate in structured sessions, and enjoy recreational football.

When not in use by the club, the area will remain open for community access, promoting wider engagement with the community and grassroots football.

We have been informed by an independent Regional Pitch Advisor who works with the Devon FA that the land is presently deemed unsafe for football activities due to surface irregularities, including undulations, mole tunnels, and divots resulting from the historical use of heavy machinery for grass maintenance.

Project Benefits

The expected benefits will be:

- To give players at Budleigh Salterton AFC Youth space to enjoy and develop at football.
- Provide a well maintained area that can be safely used by the public for sports and recreation.
- Create cost savings by utilising volunteer labour for maintenance, eliminating reliance on costly external contractors.
- Generate new opportunities for rental and shared use by other youth football teams.
- Enable broader use of the space for recreation, including a proposal already discussed with Community Interest Company, Esteem Team in Exmouth, who work with children with learning disabilities and would be grateful to make use of the space during school hours.

Proposed Works and Associated Costs

In October 2024 Ashley Hendrickx-Nutley, an independent Regional Pitch Advisor from the Grounds Maintenance Association and Nick Garlick, who leads the Devon FA's grass pitch improvement programme, both visited the land in question to make an assessment and give recommendations as to the work required to make it safe and ready for football to be played upon.

More recently on the 19th May, Ashley and Nick revisited the site to make a further assessment and new recommendations for the work required.

Funding needs

Pitch Creation Works

To ensure the land is properly developed into a safe and accessible facility, we are requesting grant funding to help towards the cost of the initial pitch creation.

Subsequent to contracted pitch creation works, maintenance of the land and regular grass cutting will be provided by volunteers of the club's youth section, with funding support sought from initiatives such as the FA Grass Pitch Maintenance Fund and other fundraising.

We contacted several sports pitch contractors and with this document have provided two like for like quotes that best fulfilled the recommendations we were given.

The first quote attached is from W. R. Sandow Ltd. and the second quote is from KePring (please see attached).

Due to travel costs, W. R. Sandow's quote is considerably more expensive and therefore our preference is the quote provided by KePring.

KePring's quote totals £9,670. However, we would be eligible for funding from the FA to cover 75% of this cost, leaving a remainder of **£2,417.50**, which we hope Budleigh Town Council could fund.

Ground Maintenance Equipment

Previously we were seeking to obtain additional funding for ground maintenance equipment in the form of a ride-on-mower and attachments. However, this will no longer be necessary as the proposed works to the newly leased land would create a more level surface that would allow us to make use of equipment already owned by the football club.

Storage Container

As storage at the main football club is currently fully utilised the Devon FA have recommended we take advantage of their Storage Container Grant to store football equipment for the youth section.

Below is a quote for the type of used storage container we have been recommended:

Once again the FA would fund 75% of this cost, meaning we would need to raise **£688**.

Ball Stop Net & Post System

To prevent balls from regularly disappearing into the field behind the ground, we would also require a ball stop net that runs along the length of the adjacent pitch.

Ball Stop Net & Post System - 120mm, 6m x 40m, £2,909 (incl VAT, delivery and discount)

Netting is another item that we can apply for 75% FA funding for, meaning we would need to pay **£727**.

Portable Lighting

To allow for us to train, play evening matches, and hire the ground to other local organisations in the evenings, we will require portable lighting. This would solve a considerable problem of there being a lack of available pitch hire for winter football use and would also allow us to save the cost of such hire.

The FA also has a fund that provides 75% of the costs for portable lighting. Based on the size of the area that would need lighting we have found the following quote:

After deducting the funding provided by the FA we would need to pay **£1,301**.

Total funds required

Below are the total costs we would like to request funding for by Budleigh Town Council after taking into account the funding available through the FA:

Pitch Creation Works, £2,417.50

Storage Container, £688

Ball Stop Net & Post System, £727

Portable Lighting, £1,301

TOTAL = £5,133.50

Other sources of funds

Since beginning our new Youth Section in October 2024 we have regularly charged players fees and have raised money through events such as our Youth Christmas Party and our recent Youth Football Tournament hosted by the club.

The money we have raised has gone towards the costs of new football equipment, artificial pitch hire, administration costs and mandatory FA training courses for our new coaches. As well as the purchase and installment of a 12ft gate to access the newly leased land.

We anticipate having used the majority of our own funds by the end of the current football season and have earmarked future player fees for the costs associated with the running of teams.

We have also been able to attach a main sponsor to the youth section who has already spent £4,520 on player and coaches kits.

Lastly, we also need to raise around £5,000 for 2 sets of aluminium goals.

Sustainability and Management

The majority of maintenance will be handled by volunteers of Budleigh Salterton AFC Youth in conjunction with advice given by professionals.

We will also look to utilise the FA's Grass Pitch Maintenance which offers tapering annual funds over a 6 year period to enhance or sustain grass pitches. This will allow us to use contractors for annual maintenance that we are unable to do ourselves such as verti-draining and herbicide spraying. We will also use this FA funding to purchase things such as grass seed, top soil and fertiliser.

Conclusion

Budleigh Salterton AFC Youth is committed to providing safe, high-quality, and inclusive football opportunities for children and families in our community. The development of our newly leased pitch space is a vital next step in this journey, allowing us to meet current demand, expand our youth provision, and provide long-term access to grassroots football for generations to come.

We are requesting grant funding to support this essential project. Ideally, we would like to obtain the full amount of **£5,133.50** to cover our contribution towards all the required works and equipment after FA grants are applied.

Our immediate priority is to obtain the funds needed to make a start on the pitch creation works as this is likely to take several months and if we do not embark on this soon it may impact on our ability to join youth league football in the 2025/26 season.

Any contribution will have a lasting impact—not only in helping young players enjoy football in a safe, local environment, but in strengthening community connections and promoting healthier lifestyles for all who use the space.

To whom it may concern,

As part of our funding application, we were asked to provide details of a bank account and accompanying statements. Initially, we submitted information for our SumUp account, which is used solely by Budleigh Salterton AFC Youth. However, as this business account is registered under the name and address of our Youth Treasurer, we understand it may not fully meet the criteria for the application.

To ensure compliance, we have also provided information for the HSBC business account used by Budleigh Salterton AFC, of which Budleigh Salterton AFC Youth is a part. We are happy for any awarded funds to be transferred to either account, depending on your requirements.

Additionally, the newly leased land referenced in our application has been deemed unsafe for football by a regional pitch inspector, in consultation with the Devon FA. The improvements we are seeking funding for are based directly on their recommendations, with the aim of making the space safe and suitable for football activities and general public use.

Due to the current safety concerns, the club's committee is reviewing whether to temporarily restrict access to the land for both players and the public. The issues identified relate primarily to ground instability caused by mole activity and soil compaction, resulting from historic maintenance practices by East Devon Council.

The work and items we are seeking funding for will directly address these concerns and allow the space to be safely used by the club and wider community.

Additionally, I've attached a screenshot from our SumUp account which shows the business information and trading name. I hope this helps to clarify that the account is registered as a business, as the bank statement I previously submitted only displays the correspondence details.

Our Club Secretary, Keith Wood, also asked me to explain that the newly leased land related to our grant application has been deemed unsafe for football use by a regional pitch inspector in conjunction with the Devon FA. The improvements we are seeking funding for are based on their recommendations to make the space safe for football activities and general public use.

Due to the current safety concerns, the club's committee will be reviewing whether to temporarily restrict access to the land for both players and the public. We understand the issues stem primarily from ground instability caused by mole activity and soil compaction due to heavy maintenance equipment previously used by East Devon Council.
